NOTICE is given that Cambridgeshire County Council has made an Order pursuant to the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Regulations 1992, the effect of which is to stop any vehicle from proceeding along The Heath, Bluntisham as lies approximately 20m either side of The Witches Twist Chicken Farm.

Access will be maintained to properties affected by this order.

The alternative route for vehicles is via The Heath, Colne - The Heath, Somersham - B1040 - B1086 - High Street, Colne - Bluntisham Road - Colne Road (C120) - Short Lane - Wood End - The Heath and vice versa.

The Order is made to facilitate new water connection works which are being carried out on or near this highway and it will come into operation on 20 December 2018 and continue until these works have finished or on the 19 June 2020 whichever is the earlier.

It is anticipated that these works will be carried out between 20 December and 21 December 2018.

The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform.
